

HugeServer Privacy Policy

We have established this Privacy policy because HugeServer takes privacy issues very seriously and wants to protect your rights any way it can. Please make sure you understand our policy on this matter and feel free to contact HugeServer if you have any questions or issues regarding this document.

Personal Information Usage

HugeServer will not search to sell, rent, lend, exchange or give your mail address, your zip code or your phone number to a third party without your explicit permission. The information provided by you are protected and cannot be accessed by an outside person. HugeServer will use the customer's personal information only as reasonably necessary to provide contracted services and to collect fees owed.

Disclosure of Personal Information

The Customer authorizes HugeServer to use its name, business name, city or country information and comments in marketing documents or as testimonials on HugeServer's website. At any time, the Customer can send a written notice to withdraw this authorization. HugeServer will only disclose personal information to a third party if required by law as evidenced by a valid Court Order of competent jurisdiction or to a collection agency if needed.

Disclosure of Non-Personal Aggregates

HugeServer could share with its partners or third parties a non-personal anonymous aggregate of information about its users or website visitors. For example, we could provide statistics data about the number of users of a particular area. The transmitted information is for statistic use only and will not reveal in any way your identity.

Contact forms and Demo Accounts

Our agents may ask you if you wish to transfer service to HugeServer during the course of your demo. If at any time you wish for us to delete your demo account and cease contact with you simply request so by contacting us and letting us know via E-mail.

From time to time, we may use customer information for new, unanticipated uses not previously disclosed in our privacy notice.
